JUNE 24, 2020 School Board Meeting

➤ Superintendent's Report

Mr. Sibeto discussed at length the PDE webinars, meetings and discussions that have been held with local Superintendents as well as administration regarding how to plan to return to school in the fall. An all-call message will go out this week from the district requesting that parents complete a survey on the district's website, HS Facebook page or via hard copies available in the Central Administration Office, which will give the district an idea of how the parents feel about sending their children back to school. In July, a special board meeting will need to be scheduled to approve a District Plan on returning to school safely that will need to be filed with PDE. Mr. Sibeto explained that the Athletics/Extracurricular Health and Safety Plan for Summer 2020 is on the agenda for board approval so that our student groups can start workouts, practices and summer camps. Once the fall seasons officially begin in August, the new plan will be developed and approved to cover actual competitions.
